

Terms and Conditions:

1. The Sealed Envelope containing Bid documents shall superscribe the address and identification of the Auction Notice No. & Date of Bid Opening along with Contact Name and Address of the interested tenderers. Envelope shall be sealed with adhesive or other sealant to prevent reopening. If the envelopes are not sealed and marked as above, the PHPA-I shall assume no responsibility for the misplacement or premature opening of bid.
2. PHPA-I may, at its discretion, extend the deadline for submission of tender by amending the tender document, in which case all rights and obligations of PHPA-I and tenderers previously subject to the deadline shall thereafter be subject to the deadline as extended.
3. The tenderer shall furnish documentary evidence as required in the tender such as copy of Valid Trade License, Valid Tax Clearance Certificate, etc. Failure to furnish any documentations required by the Tender Documents may result in the rejection of the tender.
4. The tenderers shall bear all costs associated with the preparation and submission of its tender. PHPA-I shall not be responsible for any cost of the tendering process.
5. Any tender received after deadline for submission shall be declared late, rejected and returned unopened to the tenderer.
6. Tenders submitted vide e-mail/fax/conditional offers or by electronic means are NOT acceptable and shall be rejected.
7. Each tenderer will submit only one tender, the tenderer who participate in more than one tender shall result in disqualification of the tenders.
8. The tenderers are at liberty to inspect the of New/Unused Spare Parts & Tyres of auctioned Vehicles (Tata Safari & Sonata Car).and Old & Used Spare Parts, Tyres & Batteries of Vehicles and Bikes at their own cost, before filling up the tender. It will be assumed that interested tenderers bidding for the Spare Parts, Tyres and Batteries as detailed list in **Annex-I** have been inspected at the Central Store, Gewathang before submission of tender. No complaint will be entertained after the opening of the sealed bid.
9. The tender shall be typed or written in indelible ink and shall be signed by a person duly authorized to sign on behalf of the tenderer.
10. The tenderer shall attest corrections in their rates if any, with their full signatures before submission of bid. It shall be valid only if they are signed or initialed by the person signing the Bid otherwise any overwriting or cutting or alteration which is left unsigned by the bidder shall not be considered. The Bidder shall sign each page (s) of the Bidding Documents duly endorsed with their rubber stamp/seal.
11. Tenders shall remain valid for period of 90 days from the Date of Tender Opening. Withdrawal of a Tender between the deadline for submission of Tenders and the expiration of the period of bid validity or as extended shall result in the forfeiture of the EMD.
12. Earnest Money Deposit (EMD) of **Nu. 2,000.00** (Two Thousand only) in the form of cash warrant/demand draft in favour of PHPA-I must accompany with tender, without which the relevant tender shall be summarily rejected as non-responsive. No interest shall be payable by PHPA-I on the EMD.
13. The tenderers shall sign each page of the tender documents as a token of the acceptance of the terms & conditions stipulated herein and submit along with the tender.
14. Tenders shall be delivered by hand, courier or registered post to the Office of the Executive Engineer (M), Procurement Division, Contracts & Procurement Circle, Building No. H-15D, PHPA-I, Bjimthangkha, Wangdue on or before **18.09.2025 upto 1400 hours (BST)**.
15. Bidders are free to quote for each lot or all lots given in BoQ. The bidders shall quote the amount for each Lot mentioned in BoQ. The bid will be evaluated Lot wise and Letter of Awards will comprise of all the items under each Lot awarded to the successful bidders. The list of items along with quantity is at Annex-I. The bidders have to quote amount for the lot and successful bidders will take all items included in the lot.



16. Tenders shall be opened on **18.09.2025 at 1500 hours** in the Office of the Executive Engineer (M), Procurement Division, H-15D Building, PHPA-I, Bjimthangkha, Wangdue in the presence of intending tenderers/their representatives who may wish to be present. If the specified Tender Opening Date falls on public holiday, the tenders shall be opened at same time and venue as specified in the tender documents on the next working day in presence of the tenderers/their representatives who choose to attend.
17. In case after the tender is opened, if it is observed that the two or more tenderers have quoted same highest tender amount for the New/Unused Spare Parts & Tyres of auctioned vehicles (Tata Safari & Sonata Car) and Old & Used Spare Parts, Tyres & Batteries of Vehicles and Bikes then priority shall be given to tenderer who can pay more at the post tender negotiation between them.
18. EMD of successful tenderer shall be adjusted from the total payment and the EMD of the unsuccessful tenderers shall be refunded within one (1) week after finalization of the winner Tenderer.
19. The highest tenderers will require to lift the New/Unused Spare Parts & Tyres of auctioned vehicles (Tata Safari & Sonata Car) and Old & Used Spare Parts, Tyres & Batteries of Vehicles and Bikes from the Central Store within Fourteen (14) working days from the Award of Auction Notice against full payment of auctioned value in the form Cash/Demand Draft in favour of PHPA-I, failing which, accepted bid shall be cancelled and shall result to forfeiture of the EMD. **PHPA-I shall give preference to the next highest tenderer at the matching price of highest bidder.**
20. It is the responsibility of the successful tenderer to bear all costs associated (such as arrangement of transport, labour, etc.) for lifting the New/Unused Spare Parts & Tyres of auctioned vehicles (Tata Safari & Sonata Car) and Old & Used Spare Parts, Tyres & Batteries of Vehicles and Bikes from the cited location.
21. On production of the original Money Receipt, the Central Store shall physically hand over the New/Unused Spare Parts & Tyres of auctioned vehicles (Tata Safari & Sonata Car) and Old & Used Spare Parts, Tyres & Batteries of Vehicles and Bikes sold to the highest tenderer and issue the Gate Pass enabling the highest tenderer to take out the items sold.
22. PHPA-I reserves the right to accept or reject any or all the bid without assigning any reason thereof. In case of any dispute or problem with regard to auction, the decision of Auction Committee shall be final and binding.
23. Any dispute arising out of and in relation to Award Order shall be resolved mutually, failing which the same shall be referred for arbitration as per Alternative Dispute Resolution Centre (ADRC), Thimphu, Bhutan. The parties shall follow procedures as contained in Alternative Dispute Resolution Act of Bhutan, 2013 and its Rules and Regulations.
